# 1 COMPETITION DETAILS AND STRUCTURE

## 1.1. General Information

- a) These Supplementary Competition Regulations **(Regulations)** are to be read in conjunction with the 2025 Football Queensland Advanced Rules of Competition and the Hahn Australia Cup 2025 Competition Regulations.
- b) To the extent where there is any inconsistency between these regulations and the Hahn Australia Cup 2025 Competition Regulations, the Hahn Australia Cup 2025 Competition Regulations will take precedence with regard to the Queensland Cup Men Competition.
- c) Any club who participates in the Queensland Cup Men is also participating in the Hahn Australia Cup 2025 Preliminary Rounds and is bound by the Hahn Australia Cup Competition Regulations as promulgated by Football Australia.
- d) These Supplementary Competition Regulations **(Regulations)** shall apply to all Queensland Cup fixtures administered by Football Queensland and may be amended by Football Queensland at any time.
- e) In 2025, Football Queensland will be afforded four (4) slots in the Hahn Australia Cup National Round of 32.
- f) All clubs that participate in the Queensland Cup Men, must accept the Football Australia Hahn Australia Cup 2025 Terms and Conditions and pay all applicable nomination fees as required prior to the commencement of that club's first Queensland Cup Men fixture.
- g) Terms defined in the Hahn Australia Cup Competition Regulations and/or Football Queensland Advanced Rules of Competition shall have the same meaning in these Regulations unless otherwise stated.
- h) All FQPL **(Football Queensland Premier League)** 1 Men & Women, FQPL 2 Men & Women as well as National Premier Leagues **(NPL)** Men & Women Clubs are required to register and participate in the Queensland Cup. Failure to comply may result in a club being penalised under the Football Queensland Competition Regulations, Disciplinary Regulations and appropriate By-Laws.
- i) The Queensland Cup Rounds in the Men's competition will follow a regionalised seeding based on each Club's 2025 League allocation. Provisionally, Clubs will enter the Queensland Cup at the following stages or at Football Queensland's sole discretion, contingent upon nominations received from Clubs:

- i) *In Regional Queensland, clubs may be entered in at Round One, Two or Three depending on the nominations and their progression requirements applicable to their region.*
- ii) *In SEQ All Clubs in FQPL 3 and below as well as Community Leagues will enter the Men's competition in Round Two (2);*
- iii) *In SEQ FQPL 2 Men will enter at Round Three (3) of the SEQ Component;*
- iv) *All Clubs in NPL Men and FQPL 1 Men will enter at Round Four (4) of the SEQ draw; and,*
- v) *All Regionally based clubs including but not limited to Far North Queensland, North Queensland, Whitsunday Coast, Central Coast, Wide Bay and Gulf, will play within their region in a knockout format (as stipulated based on nominations), with the regional winners then playing off for a position in the Quarter Finals.*

- i) The Queensland Cup Rounds in the Women's competition will follow a regionalised seeding based on each Club's 2025 League allocation. Provisionally, Clubs will enter the Queensland Cup at the following stages or at Football Queensland's sole discretion, contingent upon nominations received from clubs:
  - i) *In Regional Queensland, clubs may be entered in at Round One, Two or Three depending on the nominations and their progression requirements applicable to their region.*
  - ii) *In SEQ All Clubs in FQPL 3 and below as well as Community Leagues will enter the Women's competition in Round One (1)*
  - iii) *In SEQ FQPL 1 & 2 Women's clubs will enter at Round Three (3) of the SEQ Component;*
  - iv) *All Clubs in NPL Women's will enter at Round Four (4) of the SEQ draw; and*
  - v) *All Regionally based clubs including but not limited to Far North Queensland, North Queensland, Whitsunday Coast, Central Coast, Wide Bay and Gulf, will play within their region in a knockout format (as stipulated based on nominations), with the regional winners then playing off for a position in the Semi Finals (Women)*
- j) Football Queensland may amend the seeding of any Club within the draw as it deems necessary.
- k) All Fixture winners from each round will proceed to the next Round.
- l) All Round draws will be random with no separation of seeds within each round.
- m) Where required, a bye will fill any vacant slots in the draw process.
- n) Football Queensland may alter Competition Fixture dates, venues and/or kick off times and dates as it deems necessary in its sole and absolute discretion.

## **1.2. Player Eligibility**

- a) Football Queensland's 2025 Grievance, Discipline and Tribunal By-Law (RELEVANT FQ REGULATIONS) shall apply where a Club fields an Ineligible Player in any Queensland Cup Round match, or otherwise commits a breach of the Football Queensland or National Disciplinary Regulations or Hahn Australia Cup Competition Regulations where applicable.
- b) To be eligible to participate in the Queensland Cup Men's or Women's competition, male players must be turning at least 16 years (or older) in 2025,

thus born in 2009. Female players must be turning at least 15 years (or older) in 2025, thus born in 2010.

- c) All age eligible players (Boys – turning 16, 17 or 18 in 2025 & Girls turning 15, 16, 17 or 18 in 2025), are eligible to participate in the Queensland Cup U18 Boys & U18 Girls Competitions, regardless of what team they are graded into or participate in during the regular league season. Please note, any Queensland Cup games played prior to Round 1 of the regular league season will not count as grading players into any particular age level or team and no matches played in the Queensland Cup will count towards any borrowing tallies for players.
- d) Any player dispensation requests referred to Football Queensland with evidence or reasoning will be considered by Football Queensland at its sole and absolute discretion.
- e) In accordance with the Hahn Australia Cup Competition Regulations, to be eligible to play in the Queensland Cup, players **MUST** be currently registered to their Club in accordance with the National Registration, Status and Transfer Regulations and must be **ACTIVE** in Squadi prior to taking the field. In addition to the above, the following also applies;
  - i) A Player is only eligible to participate with one (1) Club in each season of the Queensland Cup. A Player will be deemed to have participated in a Queensland Cup Match where they have:
    - (1) been listed as a Player on the team sheet for the Queensland Cup Match; and
    - (2) played in the Queensland Cup Match either as a starting player or as a substitute (noting that this does not include an unused substitute.)
    - (3) For an NPL and FQPL 1 Men's Club, the team must comply with the Player Points System and relevant Registration Window requirements as prescribed in the 2025 Advanced Rules of Competition. Any player who is not ordinarily eligible for League fixtures due to their registration date being after a Registration Window, will also not be eligible for any Queensland Cup Men fixtures.
    - (4) NPL Women clubs must also comply with relevant Player Roster (including Visa Player restrictions) and Registration Window requirements as prescribed in the 2025 Advanced Rules of Competition. Any player who is not ordinarily eligible for League fixtures due to their registration date being after a Registration Window, will also not be eligible for any Queensland Cup Women fixtures.
    - (5) FQPL 2 – 6 clubs must comply with any Visa Player restrictions as prescribed in the relevant Rules of Competition.

- f) In the instance a non-NPL or FQPL 1 Men club qualifies for the National Round of 32 in the Hahn Australia Cup, Football Australia may enforce the club to adhere to the NPL PPS Requirements.

### **1.3. Substitution Regulations**

For all Queensland Cup fixtures, the following Substitution Rules will apply:

- (a) Subject to clause 1.3.1 (b) Teams may have a maximum of six (6) substitutes listed on their teamsheet. Where teams elect to name a sixth (6<sup>th</sup>) substitute, that player must be a nominated goalkeeper. Up to a maximum of five (5) Players (including a goalkeeper) may be replaced at one (1) of three (3) permitted substitution opportunity to make a substitution during a match, up until the conclusion of normal playing time, time lost or added time, if played. The replacement Player must be one of the substitutes selected on the starting list as directed above. For the avoidance of doubt, any:
  - (1) Substitutions made during the half-time break will not count towards the three (3) permitted substitution opportunities during a match; and
  - (2) Substitution or substitution opportunities that have not been used at the conclusion of normal playing time or added time, if played, such unused substitutions and substitution opportunities may be used during Extra time; and
  - (3) One (1) additional (outfield Player or goalkeeper) may be replaced and each team will have one (1) additional substitution opportunity during Extra Time of a match up until the conclusion of Extra Time (whether or not the team had already used the full number of permitted substitutes). The replacement player must be one of the substitutes selected on the Starting list.

### **1.4. Sin Bin**

- (a) The Sin Bin (utilised in all Amateur competitions in QLD in 2025) is not applicable to the Queensland Cup in 2025.

### **1.5. Disciplinary**

- (a) The 2025 Football Queensland Disciplinary Regulations and the National Disciplinary Regulations are applicable to the 2025 Queensland Cup competition.



## **2 FIXTURE REQUIREMENTS**

### **2.1. Ground Officials & Match Commissioners**

- (a) The Home Club must provide at least one (1) Ground Official as directed by Football Queensland. Failure to do so may result in disciplinary action.
- (b) Ground Officials must;
  - (i) be at least 18 years old and provide the Match Official with their name;
  - (ii) be in a clearly identifiable uniform and visible from the field of play at all times;
  - (iii) escort the Match Official(s) to and from the Referee Dressing room and the Field of Play at the commencement of the fixture, at half time and at full time; and
  - (iv) where required, assist the Match Officials(s) to ensure a safe playing environment for all Players, Club Officials and spectators.
- (c) Match Officials will not leave their dressing rooms to enter the Field of Play or return to their rooms from the Field of Play until the identifiable Ground Official/s are present.
- (d) Football Queensland may vary the Ground Official/Security requirements for any Fixture at any time if a match has been identified as a higher risk fixture. Football Queensland will communicate any additional requirements to clubs in advance of a fixture.
- (e) Football Queensland may appoint a Match Commissioner to any Queensland Cup fixture at its sole and absolute discretion.

### **2.2. Player/ Team Strip**

- a. All Clubs must have available a 'Home' and an 'Alternate' playing strip prior to the commencement of that Club's first Queensland Cup match in 2025. The 'Home' Club is the first named Club in the fixture for the purposes of strip allocation for a fixture, irrespective of where the fixture is played.
- b. The Home Club in each Preliminary Round fixture is required to wear their nominated 'Home' playing strip, unless otherwise instructed by Football Queensland.
- c. In the instance of a playing strip clash between the home and away teams as determined by the Match Official, the away team is required to provide a sufficient alternate playing strip, as determined by the Match Official and/or Football Queensland.

- d. A Club may be penalised and a forfeit win awarded to the non-offending Team if a Preliminary Round fixture does not commence due to an inability to resolve a clash of strips, and it can be established that such Club or team did not comply with Rule 2.2.c.

### **2.3. Match Balls**

- a) The Home Club shall provide the Match Official with three (3) match balls (size 5) no later than 30 minutes prior to the start of the Queensland Cup Fixture.
- b) All Clubs must use a Mitre licensed match ball as advised by Football Queensland. This can be no less than the Mitre Ultimatch Max ball for the 2025 Cup Competition.
- c) Where directed by Football Australia or Football Queensland, Clubs must use the Official Hahn Australia Cup Match Ball. In addition, all Semi Final & Final fixtures must use the Official Hahn Australia Cup Match Ball, if supplied.
- d) Any breach of the match ball licensing arrangements must be reported to Football Queensland by the Match Official. However, provided both teams participating in the fixture are aware it is not the requisite ball, the fixture is to proceed.
- e) A failure to comply with Regulation 2.3 will result in a penalty as set out in any relevant Football Queensland Regulations.

### **2.4. Results of Match**

- (a) All matches in the Queensland Cup must have a result. If the scores are tied after 90 minutes (and any applicable added/injury time at the discretion of the Match Officials), the match will progress to 2 x 15-minute periods of extra time. If the scores are still tied at the conclusion of extra time, a penalty shootout will be conducted to decide the winner.
- (b) Clubs must adhere to the requirements relating to the use of Squadi team sheet, results reporting and match data recording, as prescribed by Football Queensland through Squadi.
- (c) Clubs must list on the team sheet all players taking part in a Competition Fixture and must be submitted online no less than 60 minutes before the commencement of any Queensland Cup fixture. The team sheet will lock 15 minutes prior to the scheduled kick-off time for the fixture.
- (d) If a Club disagrees with any of the details on the team sheet prior to the commencement of the fixture, the fixture must still take place as per the fixtured

start time.

- (e) A Match Official has the discretion to amend a team sheet up until half time, but will not normally do so once a match has commenced.
- (f) A Club may be charged with Misconduct, and shall be processed in accordance with the terms of the relevant Football Queensland Regulations, if:
  - (i) any player listed on the team sheet is ineligible in accordance with either these Regulations or the Football Queensland Advanced Rules of Competition, or is subject to a suspension under the Football Queensland Disciplinary Regulations; or
  - (ii) more than 17 players are listed on the team sheet; or
  - (iii) it fails to list on the team sheet the shirt number and name for each player, or adds players to the team sheet after submission to the Match Official (and without the Match Official's permission).
- (g) If a Club disagrees with any of the details on a team sheet (either its own or the opposition's), the Club must indicate any disputed information by emailing Football Queensland Competitions within 48 hours of a completed fixture. Only the following information can be disputed:
  - (i) Goal Scorers;
  - (ii) Red and Yellow Cards
  - (iii) Final score; or
  - (iv) Player eligibility
- (h) Team sheet Disputes will only be investigated by Football Queensland in the following circumstances:
  - (i) The Team sheet and a request to conduct a match investigation is lodged with Football Queensland within 48 hours of the conclusion of the Competition Fixture and;
  - (ii) The following evidence is submitted by the Club in support of its request for a match investigation:
    - 1) Complete team sheet
    - 2) Video and/or photographic evidence;
    - 3) Any other information accepted from the Club at the discretion of FQ.

- (i) Football Queensland may extend or abridge the deadline referred to in Rule 2.4.g. at its discretion.
- (j) Football Queensland reserves the right to amend any team sheet and will only be amended if it is satisfied that there was no malice or intent to gain an advantage. In this instance, Clubs may not be charged with Misconduct. Football Queensland's determination with regard to this provision will be final and not subject to appeal.
- (k) Clubs are obliged to participate in Queensland Cup fixtures once nominated into the competition. Any Club which fails to do so may be penalised as per the following:
  - (i) The Club will be deemed to have forfeited the fixture and will remain liable for any nomination fee due in addition to forfeit fines as prescribed under the 2025 Fines & Penalties Document;
  - (ii) The Club may be subject to further disciplinary action from Football Queensland, including but not limited to the non-acceptance of future nominations into the Queensland Cup.
- (l) In the event of forfeit without adequate notification to Football Queensland, the payment of any Match Official Match Fees is entirely (100%) the responsibility of the non-participating Club. The payment will be shared (50%) if both Clubs do not participate in the fixture with both at fault.

## **2.5. Venue Requirements**

- (a) Home Clubs are required to comply with the relevant licensing criteria and Facilities Standards for the league they compete in, for the 2025 season.
- (b) Queensland Cup fixtures may be played on a pitch with a synthetic surface provided it has been constructed and maintained to at least FIFA standard or as otherwise approved by Football Queensland.

## **2.6. Lighting Standards**

- (a) Clubs wishing to play Queensland Cup fixtures under lights must ensure that the facility lighting complies with [FQ's Football Lighting Guide](#) as published.

## **2.7. Stretchers/ First Aid**

- (a) Each Home Club must allocate one (1) stretcher suitable for first aid and emergency use at all Queensland Cup fixtures.

- (b) Each Home Club must provide a First Aid Kit including, but not limited to:
  - (i) Band Aids;
  - (ii) Bandages; and
  - (iii) Ice Pack (or other available ice)
- (c) All clubs must have use and possession of a defibrillator that has been maintained and serviced in accordance with relevant regulations.

## **2.8. Hosting of Queensland Cup Fixtures**

- (a) The Club drawn first and named first on published fixtures will be the Home nominated Club.
- (b) Football Queensland may, at its sole and absolute discretion, deem that a fixture be played at a neutral venue.
- (c) Football Queensland may utilise Home Club preferences for the regular season to allocate the fixtures accordingly and account for player welfare, referee, filming and exposure requirements with the following being considered after the draft draw is distributed:
  - (i) If the Home Club is unable to provide a suitable venue the second named Club of the fixture will be given 48 hours to provide both a venue and kick off preference;
  - (ii) If any Club provides written confirmation of their inability to host the match prior to the deadlines set in Regulation 2.8, the Clubs forfeit their hosting rights including kickoff preference;
  - (iii) In the event that neither participating Club can provide a venue, Football Queensland at its sole discretion will provide a venue and allocate a kick off date and time. This shall not be appealable.
- (d) Football Queensland may alter the deadline for venue and kick off preferences at its sole discretion.
- (e) Football Queensland will determine what, if any, contributions will be made to costs incurred by clubs travelling regionally (outside of SEQ Region) for Queensland Cup fixtures on a case by case basis.

## **2.9. Security & Policing**

- (a) The Club which hosts a Queensland Cup fixture is responsible for any security and/or police as directed by Football Queensland. Ordinarily this will be wholly the responsibility of the Home listed Club but Football Queensland reserves the right to require any Club involved in a Preliminary Round fixture to meet Football Queensland determined security requirements.

- (b) All Clubs, players, Match Officials, club members, spectators and Club Officials participating in a Queensland Cup match must comply with the Football Australia Code of Conduct and Ethics as well as any other Football Queensland relevant Regulations including but not limited to the Football Queensland Disciplinary Regulations.
- (c) A breach of any of these Regulations or Codes may result in sanctions and penalties being applied to members, spectators, players, team officials, teams or clubs and can apply to the Queensland Cup as well as the league the team/club is participating in, in the 2025 season.

## 3 FIXTURE AND SCHEDULING DETAILS

### 3.1. Admittance to Queensland Cup Fixtures

- a. Conditions of Entry to Venues.
  - i. Football Queensland's and Football Australia's conditions of entry to venues apply to all matches. Each hosting Club shall display those conditions at each entry point to the venue.

### 3.2. Filming of Queensland Cup Fixtures (or Photography)

- a. Live streaming of any Queensland Cup Men fixture is at the discretion of Football Australia. If a club wishes to film their Queensland Cup Men fixture, they will be required to submit a request to Football Australia via the Preliminary Rounds Streaming Request Form.
- b. Live streaming of any Queensland Cup Women, or U18 Boys/Girls fixture is at the discretion of Football Queensland. If a club wishes to film their Queensland Cup Women, or U18 Boys/Girls fixture, they must submit a written application to Football Queensland to do so.
- c. Photographers of Queensland Cup fixtures must also comply with the Football Queensland Media and Marketing Guidelines as well as applied to Football Queensland for appropriate accreditation.

### 3.3. Match Official Fees

- (a) Queensland Cup Match Officials fees outlined below in Table 3.3.2 will apply but are subject to change at any time:

- (a) Match Officials fees are to be distributed evenly 50/50 between each team in the relevant Round fixture the Queensland Cup in 2025. Football Queensland will cover Match Official fees for all Grand Final matches.

**3.4. Fixture Time and Playing Days**

- (a) Queensland Cup Men Rounds 1, 2 and 3 fixtures will be played on either: Friday, Saturday or Sunday. Rounds 4, 5, 6 will be played midweek. Football Queensland may schedule Queensland Cup fixtures on other days as it deems necessary, or otherwise agreed by clubs. Quarter Final, Semi Final & Final fixtures will be scheduled at the discretion of Football Queensland taking into account potential inter region travel for participating clubs.
- (b) Queensland Cup Women Rounds 1 and 2 fixtures will be played on either: Friday, Saturday or Sunday. Rounds 3, 4, 5 will be played midweek. Football Queensland may schedule Queensland Cup fixtures on other days as it deems necessary, or otherwise agreed by clubs. Quarter Final, Semi Final & Final fixtures will be scheduled at the discretion of Football Queensland taking into account potential inter region travel for participating clubs.
- (c) Queensland Cup U18 Boys & U18 Girls Rounds will utilise the fixture windows as outlined in the 2025 Season Calendar, with Football Queensland to work with participating clubs on fixture details.
- (d) Weeknight (including Friday) Queensland Cup fixtures may not kick off earlier than 7:00PM or later than 8:45PM, unless the fixture has been



rescheduled or as otherwise determined by Football Queensland.

- (e) In the SEQ Region, any Queensland Cup fixture that involves the following travel scenarios will be scheduled as a weekend fixture, with any weekend League fixtures to be rescheduled to accommodate in accordance with the 2025 Advanced or Statewide Rules of Competition:

- South Coast to Darling Downs (or reverse)
- South Coast to Sunshine Coast (or reverse)
- Sunshine Coast to Darling Downs (or reverse)

Football Queensland may still schedule a fixture with the above travel scenarios to midweek with the agreement of both clubs, or if exceptional circumstances exist in the sole and absolute discretion of Football Queensland.

- (f) If the normal travel time between the home venues of the two (2) Clubs exceeds 120 minutes in any fixture, Football Queensland **may** in its sole and absolute discretion deem that the fixture be played at a neutral venue. This decision by Football Queensland is final and not subject to appeal.
- (g) Weekend Queensland Cup Men or Women fixtures may not kick off earlier than 2:00PM or later than 8:45PM, unless either fixture has been rescheduled according to Rule 3.4, or as otherwise scheduled by Football Queensland. U18 Boys or Girls fixtures played on a weekend may not kick off earlier than 11:00AM or later than 8:00PM.
- (h) Fixtures may be played on alternate days and times at the discretion of Football Queensland who reserves the right to do so, or with the written consent of both competing Clubs providing it does not negatively impact the draw or future rounds or as determined by Football Queensland.
- (i) The final scheduling, including venue allocation, of all Queensland Cup fixtures is at the sole and absolute discretion of Football Queensland.

### **3.5. Abandoned Competition Fixtures**

- (a) Clubs are required to adhere to the Football Queensland Wet Weather Policy and Process (see Football Queensland Advanced Rules of Competition) and can only cancel a Queensland Cup fixture in the event of inclement weather if;
- (i) The club has notified Football Queensland more than 3 hours prior to the scheduled fixture
  - (ii) The Local Government Area or Council has closed their fields
  - (iii) Photographic evidence is provided
- (b) Within 3 hours of the scheduled kick off time, Competition Fixtures may

only be abandoned by the Match Official.

- (c) The Competition Fixture may be abandoned for any, but not limited to, the following reasons:
  - (i) Any Team has its playing numbers reduced for any reason below the minimum IFAB requirement of seven (7) players;
  - (ii) The lighting at the venue fails such that in the opinion of the Match Official it is impossible or unsafe to continue to play;
  - (iii) the Match Official determines that playing conditions have become unsafe or untenable for any reason.
  - (iv) the Match Official, in consultation with security staff and ground marshals where applicable, determines that the conditions for players, coaches, Match Officials or supporters have become unsafe or untenable for any reason;
  - (v) One or both of the Teams is not ready to commence the Competition Fixture within 15 minutes of the scheduled kick-off time; or
  - (vi) In accordance with Rule 3.7
  
- (d) If a Competition Fixture is abandoned due to a matter set out in Rule 3.5.c, Football Queensland may determine one of the following outcomes of the Competition Fixture at its absolute and sole discretion:
  - (i) If 45 minutes or more of Normal Time (playing time) of a Competition Fixture has been played then the score at the time of abandonment may stand. 'Played' in the context of this provision will be determined by Football Queensland in communication with the Match Official.
  - (ii) If a competition fixture has been abandoned prior to 45 minutes of playing time elapsing of a competition fixture, Football Queensland may determine one of the following;
  - (iii) Competition Fixture to be replayed in full.
  - (iv) Competition Fixture to be replayed from the time at which the original Competition Fixture was abandoned. In the event a Competition Fixture is replayed in accordance with this provision:
    - 1) The score at the time of the abandonment remains the score at the time the Competition Fixture recommences; and
    - 2) Only players listed on the team sheet for the initial Competition Fixture between the two sides will be eligible to compete in the recommenced Competition Fixture, unless Football Queensland determines that additional players are eligible (for example, in the case of player injury or availability); and

- 3) Football Queensland will determine what, if any, further substitutions are allowed by each Team during the recommenced Competition Fixture, giving consideration to the number of substitutions made in the Competition Fixture before it was originally abandoned (including which players may take the Field of Play or be substituted on).
- (e) When a Competition Fixture is abandoned:
- (i) after commencement of the Competition Fixture, all Match Officials are entitled to receive 100% of their normal match fee; or
  - (ii) prior to commencement of the Competition Fixture, all Match Officials are entitled to receive 50% of their normal match fee if the Match Official(s) were present at the venue when the Competition Fixture was due to commence.
- (f) Match Officials may not claim more than one (1) postponed match fee from one venue on one day.
- (g) If a Competition Fixture is abandoned by the Match Official, both the Match Official and the Home Club must notify Football Queensland by the following working day that the Competition Fixture has been abandoned.

### **3.6. Postponed/Rescheduled Competitions Fixtures**

- (a) Competition Fixtures may only be postponed or rescheduled with the approval of Football Queensland Competitions staff.
- (b) Football Queensland may reschedule Competition Fixtures at its discretion. In exercising that discretion, Football Queensland:
  - (i) Will take into consideration all relevant circumstances including but not limited to league fixtures, league calendars and the scheduling of future Cup Fixtures.
- (c) Football Queensland will determine the new time, venue and date for the playing of a postponed/rescheduled Competition Fixture. Such decision is not open to appeal or review. Clubs are obliged to fulfill any postponed or rescheduled Competition Fixture as determined by Football Queensland and any Club which fails to do so will automatically forfeit the Competition Fixture and may face penalty under the relevant Football Queensland Regulations.
- (d) Any postponed or abandoned Competition Fixture that requires rescheduling will be rescheduled at the earliest possible date while taking in consideration the next scheduled Queensland Cup Round or as determined by Football Queensland.
- (e) Any Competition Fixture scheduled by Football Queensland to be replayed must be completed by no later than 48 hours prior to the next scheduled Queensland Cup Round or unless otherwise approved or directed by Football Queensland in writing.

- (f) Any Club Member or Club who attempts to rearrange a Competition Fixture or requesting the appointment of Match Officials outside the set kick-off time or date will be subject to Misconduct under the relevant Football Queensland regulations. Football Queensland may also record the final score of any such Competition Fixture as a 'No Result'.

### 3.7. Weather Conditions

- (a) Football Queensland and/or the Match Official may delay or abandon any Competition Fixture due to weather, pitch conditions such as but not limited to excessive heat/humidity, lightning or rain that may endanger participants health and/or safety. Refer to [FQ Heat Policy](#) and Wet Weather/[Lightning Policy](#) as needed.

## 4 MINIMUM FACILITY REQUIREMENTS

### 4.1. Field of Play & Environment

Heading	Requirement
Section 1 – Field of Play & Environment	
General	The Field of Play and related equipment including goals and corner flags must be compliant with the Laws of the Game.
Pitch Size	Length - Minimum 96 metres, maximum 105 metres Width - Minimum 60 metres, maximum 74 metres
Run Offs	A minimum runoff area of 3 metres to any tripping hazard or solid obstruction, including fences and Team benches, must be provided.
Goals	Goalposts and nets must be in accordance with the Laws of the Game.  The goalposts and crossbar must be made of metal or other approved material.  They may be square, rectangular, round or elliptical in shape and must not be dangerous to players.

	<p>The distance between the posts is 7.32 m and the distance from the lower edge of the crossbar to the ground is 2.44 m.</p> <p>Both goalposts and the crossbar have the same width and depth, which do not exceed 12 cm.</p> <p>The goalposts and crossbars must be white.</p> <p>Goals must have nets which must be secured effectively to the posts and ground to ensure the ball is trapped. The nets must be pulled back to allow sufficient safe space within the goal space.</p> <p>Permanent and semi-permanent goals must conform to Australian Standard AS 4866.1-2007 - Playing field equipment- Soccer goals Part I: Safety aspects and be properly installed and secured.</p> <p>Movable goals must be compliant with the Australian Competition and Consumer Commission's Consumer Protection Notice No.28 of 2010.</p> <p>Goals must not have sharp edges protruding that may cause injury.</p>

Corner Posts and Flags	<p>Corner posts and flags must be in accordance with the Laws of the Game. Posts must not be metal or spring loaded. They must be plastic or wood and stand a minimum of 1.5 metres above the ground with a non-pointed top. Corner flags must not feature nationalistic emblems or reference.</p>
Pitch Surface	<p>The field of play must be safe and even without trip hazards.</p> <p>If a hard-based cricket wicket is present on the field of play it must be covered with soil or be of a material similar to grass.</p> <p>The edges of the wicket must not protrude from the ground or in any way cause a tripping hazard. The field of play must be configured so that the hard cricket wicket is not located within the penalty area.</p>
Pitch Surface - Synthetic	<p>Matches may be played on a pitch with a synthetic surface provided it has been constructed and maintained to at least FIFA I star standard or as otherwise approved by FQ.</p>

Line Markings	The playing pitch must be marked in accordance with Law 1. However, Matches may be played on fields with extraneous markings provided approval has been sought from FQ with specific regard to the number of, and colour of, any marking not outlined in Law 1.
Line Marking Products	<p>Only products such as agricultural limestone or water based spray paint or other similar material which will not endanger ground users or damage turf grasses may be used for line marking.</p> <p>Lime, Herbicides and other products such as 'Round Up' that are harmful to a person's health can cause damage to the playing surface are not to be used under any circumstances.</p>
Stretcher	<p>One stretcher suitable for first aid and emergency use must be placed at the half way line prior to the commencement of each Match. The stretcher must remain inside the barrier/fence, in a safe and accessible position to first aid staff, for the duration of the Match.</p> <p>Wooden or canvas stretchers are not suitable. One stretcher may not be allocated to two pitches at any one time.</p>
Pitch Fence	Where a pitch fence is not in place at least a rope or bunting around the pitch at a height of around 1 metre and a minimum 3 metres in distance from the side lines and goal lines must be in place to provide a clear indication of segregation of the playing area.

Technical Area	<p>A Technical Area must be marked for each Team on the same side of the field and on opposite sides of the half way line.</p> <p>It must be located no closer than 7 metres and no greater than 20 metres from the halfway line.</p> <p>The technical area extends 1 m on either side of the designated seated area and extends forward up to a distance no closer than of 1 m from the touch line. A Technical Area must be in accordance with the Laws of the Game.</p>
Technical Area	The technical area must be marked in accordance with the

	line marking requirements in 1.7.2.
Technical Area	The technical area may be marked by crushable cones. If marked by lines they must be in accordance with the line marking requirements in 1.7.2.
Technical Benches	Two covered Team benches or equivalent seating with adequate seating for nine (9) people must be provided.

## 4.2. Player & Official Amenities

Section 2 – Player & Official Amenities	
Players Change Rooms	<p>Two players' lockable dressing rooms must be provided for each pitch in use. Each room must have access to hot and cold showers and to toilet facilities within the building structure.</p> <p>Recommended size for senior dressing rooms, excluding required shower and toilet area, is 25m<sup>2</sup>.</p>
Match Officials Change Rooms	Match Officials must have exclusive access to a lockable dressing room. The Match Officials room must be accessible without passing through any players' change room which is in use.
Match Officials Change Rooms	Recommended size for Match Officials rooms, including required shower and toilet area, is 20m <sup>2</sup> . The room must contain a writing desk or bench and chair and have access within the building to a toilet and shower providing hot and cold water.
First Aid	A first aid area, which can be made private by the use of curtains, screens or similar and providing basic first aid equipment all of which must be kept clean and sterile.

## 4.3. Spectator Amenities

Section 3 – Spectator Amenities	
Public Toilets	Access to male and female public toilets (or suitable unisex/family toilets) must be provided. These may be shared with player toilets.

#### 4.4. Operations

Section 4 – Operations	
Access	The venue must be accessible by emergency services vehicles.
